ARTICLES OF ORGANIZATION

OF

The undersigned, being a duly authorized representative of a Member, desiring to Ban a limited liability company under and pursuant to the Florida Limited Liability Company Accidented 608, Florida Statutes, does hereby adopt the following Articles of Organization and hereby certifies:

ARTICLE I: NAME
