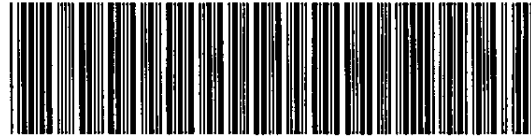

**ARTICLES OF ORGANIZATION  
OF  
JVSV, LLC**


1. Name. The name of this limited liability company is JVSV, LLC, a Florida limited liability company (the "Company").
2. Duration. The Company shall exist for a term commencing on the filing of the Articles of Organization with the State of Florida and continue perpetually even though a membership of a member is terminated.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including designing, customizing, embroidering, printing and selling at wholesale and retail items of wearing apparel, and such other lawful activities as are reasonably necessary, convenient or incidental to this purpose.


of being a member. Any Operating Agreement of the company as defined in section 608.402(24) of the Florida Statutes must be in writing and signed by all the initial members.
