ARTICLES OF ORGANIZATION

OF

The undersigned person, acting as the organizer of TEMPUS PRO SERVICES, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company will commence on December 30, 2012, and the existence of the company shall be perpetual.

ARTICLE III - PURPOSE

The business of the company shall be managed by the members in proportion to their contributions to the capital of the company, as adjusted from time to time to properly reflect any additional contributions or withdrawals by the members.

ARTICLE VIII - REGULATIONS

The power to adopt, alter, amend, or repeal the regulations of the company is vested exclusively in the members of the company.
