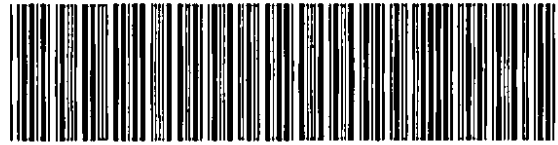

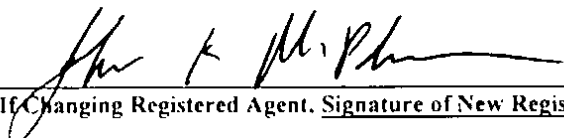

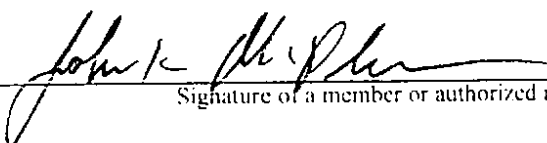

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Amended and Restated Articles of Organization.

ARTICLE I. NAME

The name of the Limited liability Company shall be Cedar Key Dock, LLC ("Company").

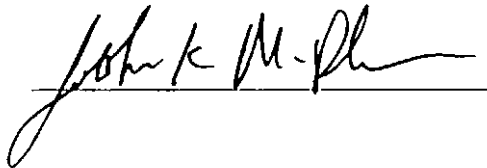

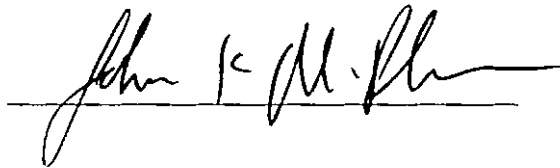
