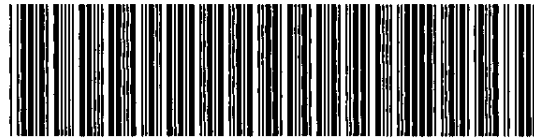

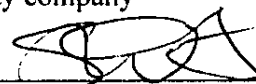

ARTICLES OF ORGANIZATION
OF

ARTICLE I -- NAME

The name of the limited liability company shall be **Misss Adventures, LLC**, ("company").

ARTICLE II -- ADDRESS

ARTICLE V -- CAPITAL CONTRIBUTIONS

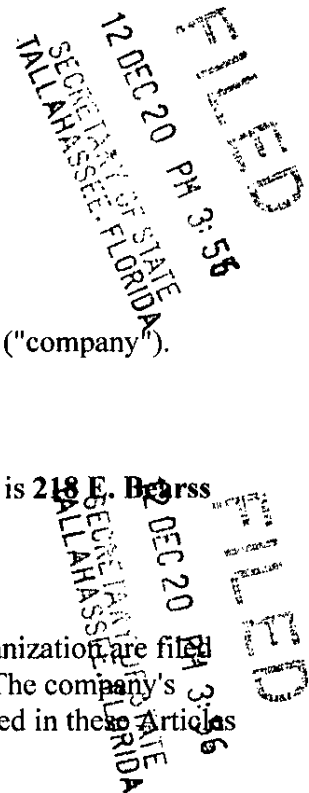
The members of the company shall contribute to the capital of the company the cash or property in the amount of \$50,000.00 for each of the Members.

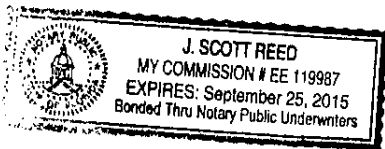
