The name of the limited liability company is: MJOB, LLC.

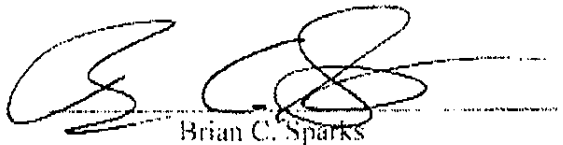

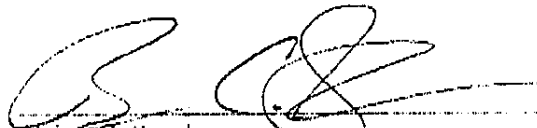
