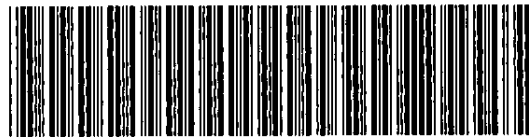

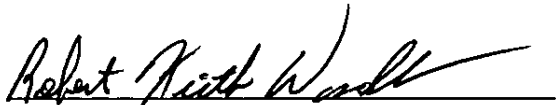

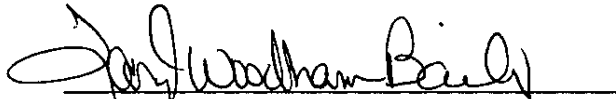
Amendment
