ARTICLES OF ORGANIZATION

OF

DAYTONA AIRCRAFT LEASING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Daytona Aircraft Leasing, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 561 Pearl Harbor Drive, Daytona Beach, Florida 32114.

ARTICLE II

PURPOSES AND POWERS
