

## ARTICLES OF ORGANIZATION OF TLT NET PLAY, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

- 1. <u>NAME.</u> The name of the limited liability company is TLT NET PLAY, LLC (hereinafter referred to as the "Company").
- 2. <u>PERIOD OF DURATION.</u> The period of duration of the Company shall be from the date of filing of its Articles of Organization until the first to occur of the following:
  - (i) Dissolution of the Company pursuant to the provisions of the Florida

    Limited Liability Company Act; or
  - (ii) By the mutual written agreement of a majority in ownership interest of the members of the Company (each a "Member" and, collectively, the "Members"); or
  - (iii) As provided for in a written Operating Agreement executed by all of the Members.
- 3. <u>PURPOSE.</u> The purpose for which the Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.
- 4. <u>ADDRESS OF PLACE OF BUSINESS.</u> The initial mailing address and the street address of the place of business for the Company is 22453 SW 66th Avenue #115, Boca Raton, Florida 33428. Such address may be changed from time to time as provided in the

Operating Agreement.

- 5. <u>REGISTERED AGENT.</u> The initial registered agent in Florida for the Company is Shelia Townsend, and the initial registered office is located at 22453 SW 66th Avenue #115, Boca Raton, Florida 33428.
- 6. <u>MEMBERS.</u> The Company shall have at least one (1) Member, and may admit additional Members upon the prior unanimous written agreement of the then existing Members, or as otherwise provided in the Operating Agreement.
- 7. <u>CONTINUITY OF BUSINESS.</u> Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of all the remaining Members (if any) of the Company.
- 8. MANAGEMENT. The management of the Company shall be reserved to its members; provided, however, that the members may appoint one (1) or more managers (each, a "Manager") in the manner provided for in the Operating Agreement. Any Manager may be (but is not required to be) a Member of the Company. The Manager(s) shall oversee the day-to-day operations of the Company and shall have the power and responsibilities provided for in the Operating Agreement.
- 9. INDEMNIFICATION. Except as expressly provided otherwise in the Operating Agreement, the Company shall indemnify any Member or former Member to the full extent permitted under the Florida Limited Liability Company Act.
