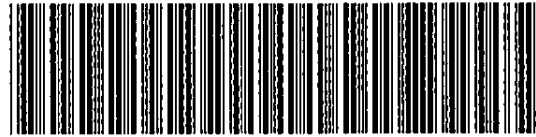




ARTICLE III


