**ARTICLES OF AMENDMENT OF
THE ARTICLES OF INCORPORATION OF
BANKATLANTIC LEASING, A FLORIDA CORPORATION**

Pursuant to the provisions of Section 601.1006 of the Florida Business Corporation Act, **BANKATLANTIC LEASING, A FLORIDA CORPORATION**, a Florida corporation (the "Corporation"), adopts the following articles of amendment to its Articles of Incorporation.

ARTICLE I

The name of the Corporation is BankAtlantic Leasing, a Florida Corporation.

ARTICLE II

Article I of the Corporation's Articles of Incorporation is deleted in its entirety and the following is substituted in its stead:
