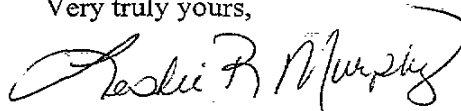
We are the accountants for the above referenced client, and are writing to you reference their Annual Report Filing.
