

# ARTICLES OF ORGANIZATION OF U.S. EDUCATIONAL OPPORTUNITIES, LLC

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

#### ARTICLE I - NAME

The name of the limited liability company is U.S. EDUCATIONAL OPPORTUNITIES, LLC, (hereinafter referred to as the "Company").

#### ARTICLE II - DURATION

Unless earlier terminated under the Act, the period of duration of the Company shall be perpetual.

#### ARTICLE III - PURPOSE

The purpose for which the Company is organized is to engage in any and all business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

#### **ARTICLE IV - ADDRESS**

## ARTICLE V - REGISTERED AGENT, REGISTERED OFFICE, & REGISTERED AGENT'S SIGNATURE

The initial registered agent in Florida for the Company is Glen C. Renaud and the initial registered office is located at 7776 Steeplechase Drive, Palm Beach Gardens, Florida 33418-7830.

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating

to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S.

#### **ARTICLE VII - MEMBERS**

The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then-existing members.

#### ARTICLE VIII - MANAGEMENT

The Company will be managed by one or more managers appointed by the members. As such, the Company will be manager-managed. The initial managing member is Glen C. Renaud whose address is 7776 Steeplechase Drive, Palm Beach Gardens, Florida 33418-7830.

#### ARTICLE IX - INDEMNIFICATION

The Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
