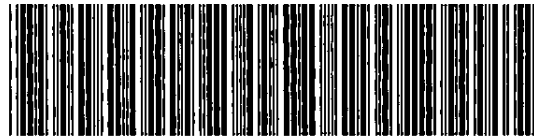

The Articles of Organization of JC Penny Realty LLC were filed on January 3, 2013, and were assigned document number L13000001277.

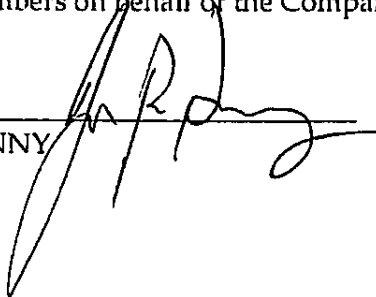
