**ARTICLES OF ORGANIZATION OF

The undersigned, GULF COAST DERMATOLOGY & SKIN CARE CENTRE, PLLC, a Florida professional limited liability company authorized to contract and the initial member of ADVANCED DERMATOLOGY & SKIN CARE CENTRE, PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 608, *Florida Statutes*.

ARTICLE I

The name of the professional limited liability company is:

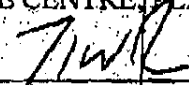
ARTICLE VIII - AMENDMENT
