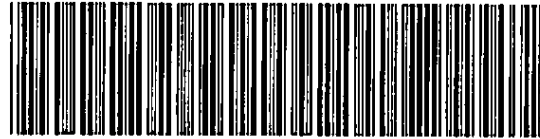

Please find enclosed forms and a cheque for \$25.00 for the dissolution of Hunter Holdings LLC. I hope that the information provided is acceptable for your needs.

Legal advice I obtained suggested that I just let the Hunter Holdings LLC registration lapse but I believed (perhaps wrongly) it was right for me to maintain the registration and related Business Bank account until all related issues to the business were concluded.

Hunter Holdings LLC (L13000001680) was registered on Jan 4th 2013 for the rental of a condominium unit. My Wife and I sold the unit on **Oct 26th 2018** and there has been no Hunter Holdings LLC business activity since then. We maintained our business bank account as I had included the account number on our Tax Return and had concerns that if the IRS issued a tax rebate to be transferred into a business account for a business that may no longer exist then this could be a problem.


I ran into a problem with 'Sunbiz' when I received a letter advising I may incur a fine if I did not maintain LLC registration so paid \$143.75 to maintain registration for 2019.

Business and personal Tax returns sent to the IRS. I received a Tax Rebate in Sept but the IRS paid me by check instead of a bank transfer. An added problem for us is that my wife has still not received her Tax Rebate. The communications with the IRS in trying to resolve the rebate issue have been long and fraught with frustration. The IRS have now agreed that they will send a check for her rebate but when we don't know.

In consequence I have now closed our Business Bank account and now through this letter and attached forms hope to dissolve Hunter Holding LLC to at last finalise the long drawn out process since selling our unit on Oct 26th 2018.

I sincerely hope that this letter and the attachments are satisfactory to you.
