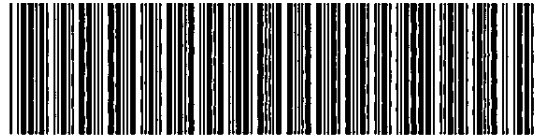

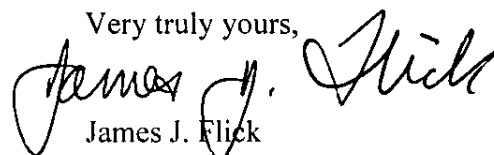

2. The "Other Business Entity" is a corporation first organized, formed or incorporated under the laws of the State of Florida on July 21, 2008.

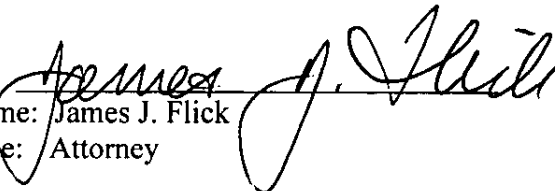

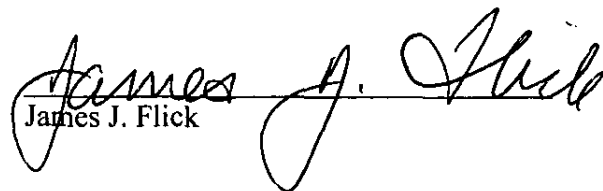

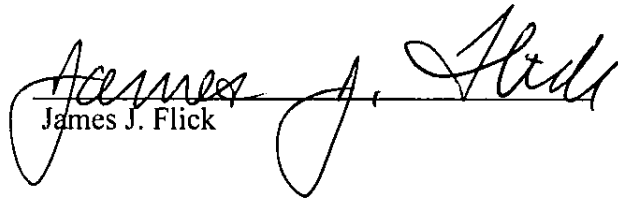
