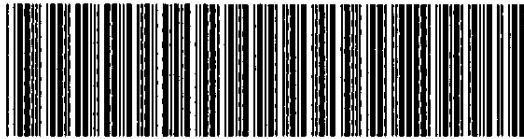



## **ARTICLES OF ORGANIZATION**

#### **ARTICLE VI - MANAGEMENT**


The Company shall be managed by the members in accordance with an Operating Agreement adopted by the members for the management of the business and affairs of the

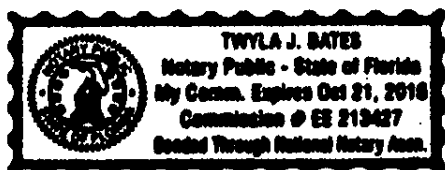




