#### ARTICLES OF ORGANIZATION

OF

STATE TARY OF STATE MYLLIGH OF CORPORATIONS

## Fox/Latimer Holdings, LLC 13 JAN -4 AM 10: 49

The undersigned person, acting hereby as Organizer for the purpose of forming a limited liability company under the Florida Statutes, Chapter 608, hereby executes the following Articles of Organization:

- I NAME. The name of the limited liability company shall be: Fox/Latimer Holdings, LLC ("Company").
- II ADDRESS. The mailing address and street address of the principal office of the Company shall be 2006 NW 19th Lane, Gainesville, FL 32605.
- III **DURATION**. The Company shall commence its existence upon filing of these Articles of Organization, and its existence shall be perpetual, unless the Company is dissolved as provided in these Articles of Organization.

However, the business of the Company may be continued by the consent of all the remaining members.
- VIII MANAGEMENT. The Company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
