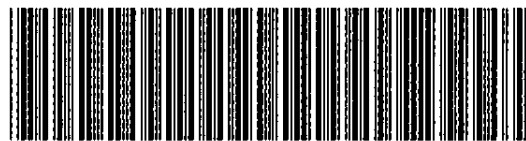

ARTICLES OF ORGANIZATION

OF
