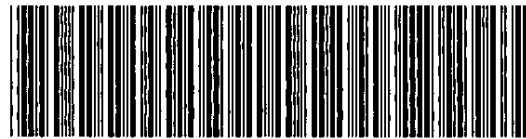



ARTICLE VI - MANAGEMENT






