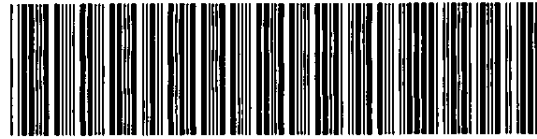

SECOND: The following amendment to the Articles of Organization was adopted by the limited liability company:


The business of this limited liability company shall be conducted by two (2) Managers who shall be elected by the Members in accordance with the Operating Agreement.
