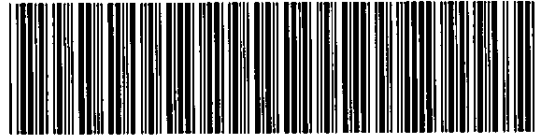


If you recall, I spoke to ^{you} regarding our need to swap the names on two Entities Filed with Sunbiz.org.


