TO

Pursuant to Florida Statutes Section 605.0202, the Articles of Organization of MARTEL REALTY, LLC (the "Company") filed on January 9, 2013, and assigned Document Number L13000004797, are hereby amended as follows:

Article IV of the Articles of Organization is hereby deleted in its entirety and replaced with the following new Article IV:

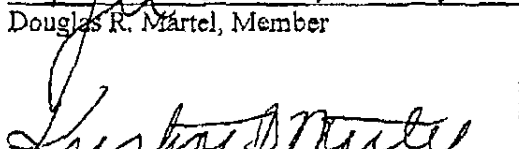
ARTICLE IV
