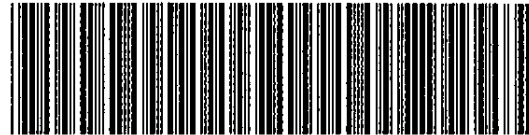

I appreciate your taking the time to speak with me this afternoon. I am also pleased that you agreed with my assertion that there does not exist within Florida Statutes Chapters 608 and 621 any requirement to set forth the specific purpose of the entity within the Articles of Organization.

The undersigned, for purposes of forming a professional limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, and the Professional Services Corporation and Limited Liability Company Act, Florida Statutes Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.
