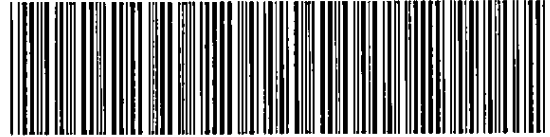

The name of the registered agent is **Sarah M. Blake** and whose Florida street address is **530 S. Main Street, Winter Garden, FL 34787**.

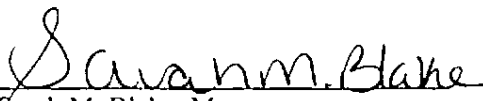
