**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME AND ADDRESS**

The name of the limited liability company shall be Midwest Mountain Sunshine, LLC (the "*Company*"). The mailing address and street address of the principal office of the Company in Florida shall be 3027 St. Johns Avenue, Jacksonville, Florida 32205.

**ARTICLE II**

MANAGER

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. 
