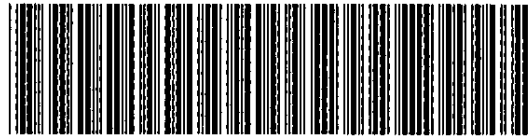




ARTICLE VII


