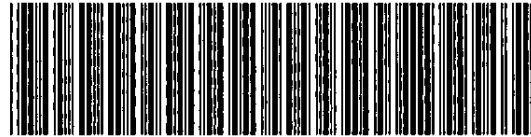

ARTICLE I – NAME

The name of the Limited Liability Company shall be **OCEANSIDE GETAWAY, LLC** (the “Company”).
