**ARTICLES OF AMENDMENT  
TO THE

Constantino, Nelson & Werline, LLC (the "Company"), a limited liability company organized and existing under the laws of the State of Florida, pursuant to Articles of Organization filed on January 14, 2013, as document number L13000007037, hereby certifies as follows:

The undersigned, being a Manager of the Company, in lieu of a special meeting, adopts the following resolution amending the Articles of Organization:

RESOLVED, that Article 1 of the Articles of Organization filed with the Secretary of State of the State of Florida be amended to read in its entirety as hereinafter set forth:
