ARTICLES OF ORGANIZATION OF

SOPHIA GRUNEIRO, LLC

ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be SOPHIA GRUNEIRO, LLC and the mailing address and street address of its principal office shall be 18308 Murdock Circle, Suite 109, Port Charlotte, FL 33952, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.
