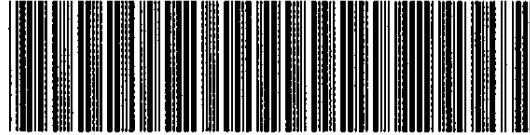

The purpose for which the Limited Liability Company is organized is:

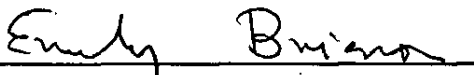
- (i) To engage in the business of fixing, rehabilitating, and repairing computers and electronic machines or equipment for individual owners, and businesses.

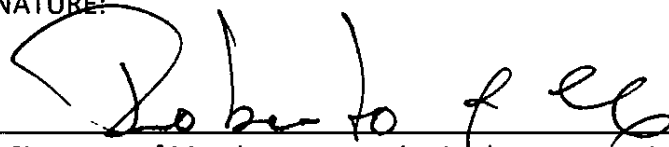
