ARTICLES OF ORGANIZATION OF

PELICAN COVE 202, LLC

We, the undersigned natural persons competent to contract, hereby organize and form a limited liability company under and pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE 1.

Name of Limited Liability Company

The name of this limited liability company shall be Pelican Cove 202, LLC.

ARTICLE 2.

Period of Duration
