

ARTICLES OF ORGANIZATION
OF
HUESTON & COMPANY CPA, LLC

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be HUESTON & COMPANY CPA, LLC.

ARTICLE II - ADDRESS

THE MAILING ADDRESS and street address of the principal office of the Limited Liability Company shall be 8792 SR 70 East, Suite B, Bradenton, Florida 34202.

ARTICLE III - DURATION

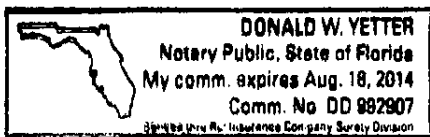
