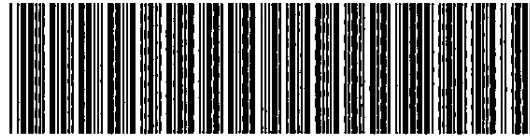

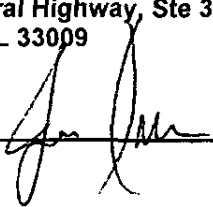

The name of this Limited Liability Company is REDLINE ASSOCIATES, LLC. (hereafter referred to as the "Company").

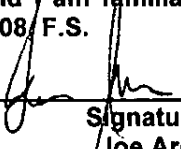
**ARTICLE II**

**REGISTERED OFFICE AND AGENT**

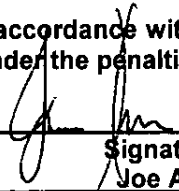
