Frasier Hansen, a natural person competent to contract and a member of Idyll Hounds Brewery, LLC, hereby presents these Articles of Organization as the Articles of Organization of Idyll Hounds Brewery, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Idyll Hounds Brewery, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS


