ARTICLES OF ORGANIZATION OF

TILLMAN REALTY, LLC

ARTICLE I Name and Address

The name of the limited liability company shall be **TILLMAN REALTY, LLC**. The street address of the principal office of the limited liability company is: 15271 McGregor Boulevard, Suite 3, Fort Myers, Florida 33908. The mailing address of the principal office of the limited liability company is: 15485 Omai Court, Fort Myers, Florida 33908.

ARTICLE II Duration

This limited liability company shall be perpetual.

ARTICLE III Purpose

This limited liability company is created for the purpose of serving as a real estate company and all purposes related to real estate and such other business as may be decided.
