

AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF

The Articles of Organization for this Limited Liability Company were filed on January 16, 2013 and assigned Florida document number L13000008986.

The Articles of Organization are being amended and restated as hereinafter set forth, to provide that the Limited Liability Company is to be manager - managed by Joy Lynn Gordon - Phillips and to remove Edward M Hewes of Milton, Florida, Henry G. Saam, IV of Pensacola, Florida, and Walter A. Bell of Gulf Breeze, Florida as managing members. All other provisions of the Articles of Organization, as originally filed, remain the same and unchanged.


FIRST: The name of the Limited Liability Company is Joy Gordon Construction, LLC.


