## <u>DEFAULT FINAL JUDGMENT, ORDER OF DISSOLUTION,</u> <u>AND PERMANENT INJUNCTION</u>

THIS MATTER is before the Court upon Plaintiff Bayview Loan Servicing, LLC's Motion for Default Final Judgment as to Defendant Bayview Loan Servicing of S FL, LLC ("Defendant" or "BLSofSFL"). The Court has carefully reviewed said Motion and the entire Court file and is otherwise fully advised in the premises.

Defendant BLSofSFL was duly served on May 31, 2013. Said Defendants failed to file an appropriate responsive pleading within the time frame prescribed by law. A clerk's default was entered against said Defendant BLSofSFL on June 26, 2013.

The well-pleaded allegations of the Complaint are deemed to have been admitted by Defendant BLSofSFL by virtue of their default. Thus, the Court finds that the aforementioned Defendant has violated Florida Statutes 608.449 by making false statements to the Florida Department of State and Division of Corporations and obtained its articles of incorporation through fraud under Section 608.449 of the Florida Statutes (2012). Moreover, Defendant

Only Plaintiffs Aformy, appeared.

BLSofSLF was not organized for any legal purpose as required by Section 608.403 Florida Statutes (2012). The Court further finds that under Section 86.021 of the Florida Statutes (2012), Plaintiff is the senior user of BAYVIEW LOAN SERVICING trademark in connection with financial services.

This action was heard after entry of default against defendant and

## IT IS ORDERED and ADJUDGED that:

- 1. The Court has jurisdiction over the parties hereto and the subject matter herein;
- 2. Plaintiff Bayview Loan Servicing LLC's Motion for Entry of Final Default Judgment, Decree of Dissolution, and Order for Permanent Injunction as to Defendant BFLofSFL is hereby GRANTED.
- 3. The Court directs the Florida Department of State to dissolve Bayview Loan Servicing of S FL LLC;
- 4. The Court directs the Division of Corporations, Florida Department of State to dissolve Bayview Loan Servicing of S FL LLC;
- 5. The Court enters a decree dissolving Bayview Loan Servicing of S FL LLC;
- 6. Defendant and its agents and representatives are barred from using the name "Bayview Loan Servicing;"
- 7. Defendant and its agents and representatives are barred from acting as an agent for Plaintiff;
- 8. Defendant and its agents and representatives are barred from making any representations of being affiliated with or associated with Plaintiff;
- 9. Defendant and its agents and representatives are barred from operating as a business under the name of Plaintiff and using Plaintiff's address;
- 10. Defendant and its agents and representatives are barred from opening up bank accounts in the name of "Bayview Loan Servicing."
- 11. Plaintiff is senior user of the service mark "Bayview Loan Servicing;"
- 12. Defendant's use of "BAYVIEW LOAN SERVICING" or any similar variation thereof, is likely to cause confusion, cause mistake, or to deceive;

- 13. The Court enters a permanent injunction that Defendant is barred from using Plaintiff's service mark "BAYVIEW LOAN SERVICING;"
- 14. The Court orders that that Defendants, their officers, agents, servants, employees and those persons in active concert or participation with them who receive actual notice of the Order by personal service or otherwise, be preliminarily and permanently enjoined and restrained from engaging in false advertising, or making false or misleading claims, including without limitation, making any claims that Defendant Bayview Loan Servicing of S FL or any of its agents, members or representatives are related to Plaintiff Bayview Loan Servicing, LLC in any manner;
- 15. That Plaintiff Bayview Loan Servicing, LLC be awarded such other and further relief as the Court may deem just and proper.
