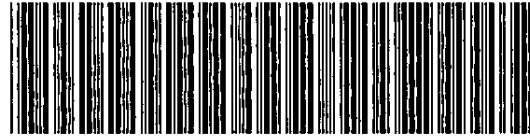

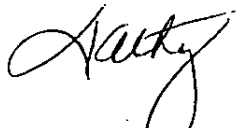

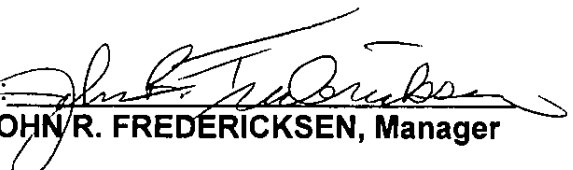
The name is changed from **350 BLACK SPRINGS LN, LLC** to **3096 TOBAGO AVE, LLC**.
