1. The Company's Articles of Organization are hereby amended by deleting Article V in its entirety and inserting a new Article V to read as follows:

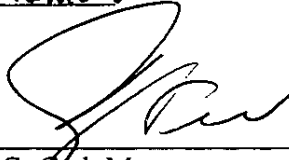
