ARTICLES OF MERGER OF ADVANCED SETTLEMENTS, INC. WITH AND INTO ADVANCED SETTLEMENTS, LLC

Pursuant to the provisions of Section 608.438 of the Florida Statutes, the undersigned hereby adopt the following Articles of Merger:

ARTICLE I - PLAN OF MERGER

The Plan of Merger of ADVANCED SETTLEMENTS, INC., an Ohio corporation (the "Corporation"), document number F04000000425, with and into ADVANCED SETTLEMENTS, LLC, a Florida limited liability company (the "LLC"), with the LLC being the surviving entity, is set forth below:

- At the effective date of the merger, all ownership and economic interests of the LLC issued and outstanding immediately prior to the merger shall remain issued and outstanding and shall be unchanged as a result of the merger.
- The shareholders of the Corporation will receive no consideration other than LLC membership rights for their shares.
- At the effective date of the merger, each share of common stock of the Corporation, issued and outstanding shall be converted into a tenth of a percent (.1%) membership interest of the LLC. The total consideration that the shareholders of the Corporation shall therefore receive for each one (1) share of outstanding common stock of the Corporation shall be a tenth of a percent (.1%) membership interest in the LLC.
