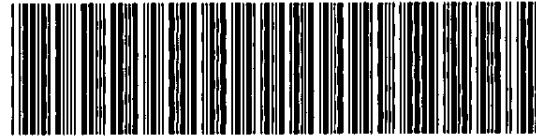

ARTICLES OF ORGANIZATION  
OF  
GEN RESOURCES, LLC

1. Name. The name of this limited liability company is **GEN RESOURCES, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
2. Duration. The Company's existence shall be perpetual.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
4. Place of Principal Office. The street address of the Company's principal office and the mailing address of the Company is 5815 Live Oak Road, Lakeland, Florida 33813.
