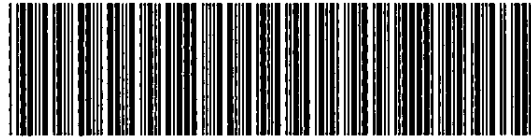

**ARTICLES OF ORGANIZATION OF
SORRIDI BUSINESS CONSULTING, LLC**

(Pursuant to Section 608.407, Florida Statutes)

ARTICLE I - NAME

The name of the limited liability company is SORRIDI BUSINESS CONSULTING, LLC.

ARTICLE II - ADDRESS
