**ARTICLES OF ORGANIZATION
OF
J REAL ESTATE, LLC**

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

**ARTICLE I
Name**

The name of the limited liability company shall be J REAL ESTATE, LLC.

**ARTICLE II
Address and Place of Business**

**ARTICLE III
Period of Duration**

The operating agreement shall be repealed or altered only by the members of the limited liability company, in the manner now or hereafter prescribed by the laws of the State of Florida.
