ARTICLES OF ORGANIZATION
OF
LEE ROAD-MEMBER, LLC

THE UNDERSIGNED, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608 (the "Act"), hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **LEE ROAD-MEMBER, LLC** (hereinafter called "Company"). The principal place of business of the Company in Florida shall be in Brevard County.

The nature of the business and of the purposes to be conducted and promoted by the Company is to engage solely in the following activities:

1. To be the only member of Lee Road-Schippers, LLC, a Florida limited liability company created solely for the purposes set forth in its Articles of Organization, which include primarily the operation of real property situated in the City of Orlando, Orange, County, Florida presently known as "Comfort Inn" located at 626 Lee Road, Orlando, FL 32810
2. To own, hold, sell, assign, transfer, operate, lease, mortgage, pledge and otherwise deal with the Property.
3. To exercise all powers enumerated in the Act necessary or convenient to the conduct, promotion or attainment of the business or purposes otherwise set forth herein.

An operating agreement adopted by the members of the Company may contain any provision for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.




