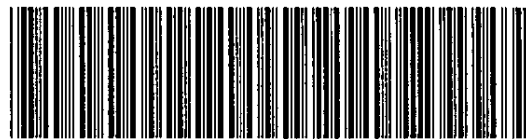

FIRST: The name of the limited liability company is PHYSICAL REVOLUTION, LLC.


