ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF ALTAMONTE SPRINGS CARMEL CAFE & WINE BAR, LLC

2. The amendment to the Articles of Organization being effected hereby will add Article VI to the Articles of Organization as of the date hereof.
