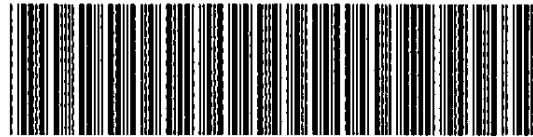

**ARTICLES OF ORGANIZATION OF

**ARTICLE I
NAME**

The name of this Limited Liability Company shall be: ALMI INTERNATIONAL, LLC

**ARTICLE V
REGULATIONS**

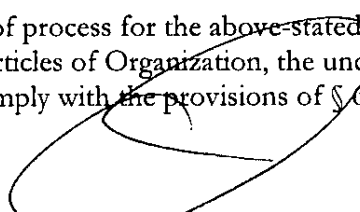
