**FIRST:** The name and address of this Company is **THE LAW FIRM OF JUSTINE A. MIKOLAÏTIS, LLC**, 901 Ponce de Leon Boulevard, Penthouse Suite, Coral Gables, Florida 33134.

**SECOND:** The Articles of Organization were filed on January 29, 2013, effective February 13, 2013 and assigned document number L13000014777.

**THIRD:** The date of the adoption of these Articles of Dissolution is February 19, 2013.

**FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421. The remaining property and assets have been distributed among its members in accordance with their respective rights and interests.
